





- You will need to show that you've laid the foundations for change, including strong partnerships; community empowerment and participation; effective leadership; crosssector delivery partnerships, and coherent improvement and investment plan
- We hope this will unlock the financial resources your place needs to implement its plans.

Capacity Building Grant



A **grant** to create headspace and capacity in local partnerships

- Space to develop ambitious place-wide strategies, project pipelines and the case for investment
- Will enable work towards new operational and delivery models with communities and other local partners
- Will support creation of new funding mechanisms and business models
- £15million available across the UK

Why has it helped?

Our project: Parks for Health

- Parks for Health was a collaborative project between the Camden and Islington Parks and Open Spaces teams and the shared Public Health team, determined to ensure that parks are used, enjoyed and maintained as health assets for their local communities
- Between the boroughs we received £800k in funding and a wealth of in-kind support
- The project also leveraged in time and focus from a wealth of stakeholders and groups



What we have learnt


- We had an idea, without the funded project we really wouldn't have got to where we are
- Internally
 - We have changed our practice with a new focus
 - We have a language that is understood across the Council
 - The project has increased our recognition and understanding of the service
- Externally
 - Positive discussions with our communities
 - We gained contacts locally, regionally and nationally
 - Direct support and involvement from so many sectors




Why you should apply

- Making new connections and learning from everyone
- A development grant at a time when the purse strings are very tight helps to explore big changes that make a difference
- It's not just the Council that will benefit

"it's a powerful thing, if you're a voluntary sector organisation, particularly a small group and you're trying to raise some funds and you know that it's kind of been endorsed by two parks departments and Public Health, your activity to take place in the park, that's powerful stuff for a funder."

Capacity-building grant



- £250,000 to £1million
- £15m in investment in total
- Spread across the whole UK
- Mandatory Expression of Interest (EoI)
- Single-round application process
- One application window
- Standard Heritage Fund process with additional considerations detailed in SI guide
- 2 to 3 years delivery
- 5% partnership funding for up to £1million
- The four Investment Principles will apply

Investment Principles

Saving heritage

What we mean

Our support will ensure heritage remains accessible, relevant, sustainable and valued.

What we will do

- Protect, conserve and revitalise heritage at risk
- Invest in places to connect people with the heritage of their natural and historic environment
- Invite proposals to develop the skills, capacity and innovation to sustain and manage heritage

Organisational sustainability

What we mean

We will support organisations to develop the skills and capacity to ensure a sound long-term future and encourage new heritage investment that benefits communities and economies

What we will do

- Support financial sustainability
- Support heritage skills development
- Provide flexible funding
- Champion the use of more diverse income sources

Protecting the environment

What we mean

We will support natural heritage and environmentally sustainable projects that help the UK meet its nature recovery targets and mitigate the impact of climate change on heritage.

What we will do

- Increase our support for landscape scale projects
 - Invest through partnerships to help halt and reverse the loss and decline of habitats and species
 - Support heritage projects that reduce adverse environmental impacts and help heritage adapt to our changing climate
 - Collaborate to bring stakeholders together to mitigate climate risks and being about positive behaviour for change

Inclusion, access and participation

What we mean

We will support organisations to ensure everyone has opportunities to learn, develop new skills and explore heritage, regardless of background or personal circumstances

What we will do

- Involve a more diverse range of people in heritage
- Enable organisations to remove barriers to access and participation
- Support all communities to explore and share their heritage
- Support accessible digital heritage resources



NOT intended for capital projects

Focus on towns or cities NOT single sites

Transformational plans for change

Provide headspace and capacity in stretched teams and organisations:

- Collaborate & partnership across sectors, organisations and departments
- Think long-term about strategy and future development of urban green space
- Invest in skills and the next generation of leaders
- Foundations for ambitious change
- Learn from others
- Innovate where there are no existing solutions
- Create new financial and operational models
- Support places to be part of an active peer network

What are we looking for?



- Focus on all the public urban green and blue spaces across an entire place
- Set out how you will lead for ambitious change
- Demonstrate partnership working benefits and impact
- Identify what resources or support you will need
- Allocate resources and capacity to join regular online network events and cohort learning sessions

Who can apply?



We encourage you to work with other people to develop and carry out your project

- Applications are open to not-for-profit organisations, and partnerships led by not-for-profit organisations, from across the UK
- If you plan to work with any other organisations to carry out a significant proportion of your project, you must formalise your relationship with a partnership agreement
- If you are making a joint application, you will need to decide which organisation will be the lead applicant
- We usually expect the owner of the heritage (the public green space) to be the lead applicant. If the lead applicant is not the owner of the heritage, we usually ask them to sign up to the terms of grant
- If private owners or for-profit organisations are involved in the project, we expect public benefit to be demonstrably greater than private gain

Expression of interest (EOI)



Mandatory stage

Online form approximately 1-2 page long

Bespoke help notes provided on EOI questions

Who, why, what and how ready they are to take part

Open for EOIs on Tuesday 01 October 2024

Close to EOIs 12 Noon Tuesday 12 November 2024

It is estimated that 30/40 will be invited to full application - outcome communicated via email mid-December

Fixed application window to apply – 16 December 2024 to 12 Noon 07 March 2025. Decisions June 2025.

Additional supporting document:


- Email us a Word document containing the following information:
 - a list of partners and organisations you intend to work with
 - an Ordnance Survey type map of the total area across which you intend to work
 - an estimation of the total area of public green space that you intend to work across in hectares
 - the total population that lives within your project area

The document should be no longer than two A4 pages. Please email it to: NTC@heritagefund.org.uk.

- Start your project title with #NTC so we can identify it as part of this strategic initiative
- Ensure you email us the additional supporting word document
